The blank examination forms can be had from the Superintendent SSC (Conduct) on requisition letter issued by Head of Institution for which **Rs: 50/-** for each candidate should be remitted to the Board in shape of DD / Bank Challan at the time of submission of examination forms. The enrolment fee of **Rs: 160/-** per candidates shall also be payable by each student of Class IX **Regular** at the time of submission of examination forms through DD / Challan.

In order to avoid botheration faced by the institutions, while submitting the examination forms, the dates for receiving the forms (without late fees) by the Board Office have been fixed separately as under:-

The Examination forms with late fees be deposited in Board's Office on the next working day of the DDs.

The above schedule of submission of DDs/Pay orders including examination forms may please be followed in letter and spirit. In case of delay of even one day, the Head of the Institution shall have to pay the usual late fee.

1. ELIGIBILITY FOR CANDIDATES OF DARSI-E-NIZAMI GROUP.

- (i) The candidates having passed sanad-ul-sanvia course from the wifaq of Deeni Madarsahs or Class VIII from Secondary School will be eligible to appear as private candidates in the said examination

OR

- (ii) A candidate who attended regular Classes in the course of SSC (Darsi-e-Nizami) Group at any affiliated Deeni Madarsah or Secondary School is eligible to appear at SSC (Darsi-E-Nizami) Examination.

2. ELIGIBILITY OF EX - CANDIDATES

- (i) The candidates who appeared at the SSC-II (Class X), Annual Examination 2007 1st Time and could not qualify at SSC-II Annual Examination 2008 and not availed of the chance of Supplementary Examination-2008 are eligible to appear at the SSC-II Annual Examination 2009, combined i.e. all the papers of Part-I&II (Class IX & X) as a **LAST CHANCE**.

(ii) The regular candidates who appeared at SSC Part-I (Class IX) Annual Examination 2007 and could not appear at SSC Part-II Annual Examination 2008 can appear at SSC Part-II Annual Examination 2009 subject to production of admission certificate of Class X with atleast 75% attendance for current session from the Head of Institution with prior permission from the Board, on or before the date of submission of Examination Forms. The private candidates of such category can also appear at SSC-II Annual Examination 2009 with prior permission of the Board.

INSTRUCTIONS

1. The particulars of the candidates i.e. name, father's name and surname should please be written in block letters, in the columns provided in the Examination form.
2. The original marks certificate of last examination & in case of improvement, original permission letter for improvement should be attached with the examination form
3. Home address of the candidates be clearly mentioned in their forms in legible writing.
4. In case any candidate exhibits irregularity in attendance, his/her name may be recommended for withdrawal of the Examination form and he/she will not be allowed to take the examination.
5. The subjects of the candidate in which, he / she intends to appear at the examination be clearly mentioned in the Examination form as well as in Admission Slips in prescribed column, as per marks certificate / option while getting admission in the Class with selection of subjects. The Board will not be responsible if any paper (s) is/are left unentered in the Examination form and any entry left unchecked / uncorrected by the School
6. In case of candidate (s) migrated from other Boards, the original eligibility certificate issued by this Board should be attached with the Examination form, as well as original marks certificate of last Examination, as the case may be
7. Photographs of the male and female candidate (s) must be pasted at proper places in the form and slips with Gum only and should not be stapled.
8. The Examination forms and admission slips must be signed by the candidate(s) and the Head of the Institution (s) himself / herself with official stamp. (STAMP SIGNATURE IS NOT ACCEPTABLE)
9. In case of ex-candidate (s), the marks certificate of Class IX & X must be attached with the form.
10. It has been observed that the form of the candidate (s) who has / have availed of all the chances and is / are not eligible at the examination is / are forwarded and submitted, resulting hardship to the candidates and the Board for refund of fees etc. In this regard it has clearly been mentioned the eligibility of such ex-candidates who are eligible to appear at this examination. Hence inspite of this, if any form of ineligible candidate is submitted, the Institution concerned shall be responsible.
11. The attendance should be counted and entered in the examination form upto **05-01-2009** plus average attendance upto **15-03-2009**
12. The Original Mark Certificate of Class IX / X as the case may be must be attached with the examination form.
13. DD No. / Challan with date and amount must be mentioned in the columns provided in the Examination form.

The Heads of Institutions are requested to kindly fill up the forms carefully ensuring that all the formalities are fulfilled well. If any discrepancy is found there in the form, the same should be rectified at the Board's Office else such forms will be rejected and the Board will not be held responsible for that.
